RoHS 2, REACH, and Toxics in Packaging Statement
SCS Static Shielding Bags and Moisture Barrier Bags

SCS Static Shielding Bags and Moisture Barrier Bags fall outside the scope of the RoHS 2 2011/65/EU directive. The European directive is to control hazardous substances (RoHS Reduction of Hazardous Substances) in a number of categories. SCS Static Shielding Bags or Moisture Barrier Bags are not included in any of the RoHS 2 categories.

However, none of the following materials have ever been intentionally added in manufacturing of SCS Static Shielding Bags or Moisture Barrier Bags: dimethyl fumarate, as well as lead, mercury, cadmium, hexavalent chromium, polybrominated biphenyls (PBB) or polybrominated diphenyl ethers (PBDE) as outlined in Directive 2002/95/EC Article 4.1.

Regarding Toxics in Packaging legislation and SCS Static Shielding Bags and Moisture Barrier Bags, the sum of the concentration levels of incidentally introduced lead, mercury, cadmium, and hexavalent chromium present is not detectable.

Regarding European Regulation REACH 1907/2006/CE (Registration, Evaluation and Authorization of Chemicals) SCS Static Shielding Bags or Moisture Barrier Bags should be considered an article under the REACH guidelines. They do not contain substances intended to be released under normal or reasonably foreseeable conditions of use. As such, there is no obligation for registration or notification under the REACH Directive.

However, none of the REACH substances of very high concern as of 2015-06-15 have ever been intentionally added in manufacturing SCS Static Shielding Bags or Moisture Barrier Bags.

The product composition information is to the best of our knowledge and may be based on third party supplier information and/or our knowledge and experience regarding typical substance composition found in materials used in ESD control and other products.
